Your current priorities for this neighbourhood

Parking issues around Clowne Junior and Infant schools, incorporating Ringer Lane, King Street and Rood Lane

Issue was set on 04/04/2016

- ▶ Police patrols will be stepped up around local schools at key times including drop off and pick up times.
- ▶ Officers will be advising motorists and carrying out enforcement if necessary.
- ▶ They will be working with schools to encourage safe and responsible parking at start and finishing times.
- ▶ Working with partner agencies to help educate youngsters about road safety and give them training.
- ▶ Teaching local youngsters about alternative ways of getting to school including cycling, walking and scooting.

Actions and outcomes from previous priorities

Anti-social behaviour and criminal damage at Chestnut Drive

Issue was set on 14/04/2014

- ▶ Increased patrols carried out in the area alongside the CAN Rangers to deter the behaviour.
- ▶ Advised youngsters about the consequences of their behaviour and further action taken where necessary.

Anti-social behaviour and nuisance motorcycles around Linear Park and the skate park, Rectory Road, Clowne.

Issue was set on 23/06/2012

- ▶ Increased patrols in the area.
- ▶ Advised youngsters about the consequences of their behaviour and further action taken where necessary.
- ▶ Seized alcohol from any underage drinkers.
- ▶ Issued warnings and seized motorcycles where necessary.
- ▶ Issued warning letters to parents and considered the use of acceptable behaviour contracts as appropriate.

Thefts from gardens on Church Street

Issue was set on 18/09/2012

- ▶ Increased police and CAN Ranger patrols.
- ▶ Liaised with Guinness Northern Counties housing association to consider improving lighting and security along the rear of College View.
- ▶ Worked with Bolsover District Council and Clowne Parish Council to consider CCTV for the area.
- ▶ Encouraged local residents to report any suspicious activity to police on 101, the non-emergency number.

Anti-social behaviour around Rectory Road, Mill Street and at the skate park area in Clowne

Issue was set on 14/04/2014

- ▶ Increased patrols in the area.
- ▶ Advised youngsters about the consequences of their behaviour and further action taken where necessary.
- ▶ Seized alcohol from underage drinkers.
- ▶ Issued warning letters to parents and Acceptable Behaviour Contracts set up where appropriate.

Littering and damage in the area surrounding the Community Centre, on Recreation Close

Issue was set on 04/03/2013

- ▶ Increased patrols in the area alongside CAN Rangers to deter the behaviour.
- ▶ Appropriate action taken against anyone found causing damage to the area.

- ▶ Worked with local agencies, including the district and parish councils, to clear litter from the area and to consider longer term solutions.

Nuisance motorbikes in Clowne

Issue was set on 07/07/2014

- ▶ Regular patrols were carried out in areas where reports were received of nuisance off road bikes being used.
- ▶ Residents were encouraged to contact police to report any incidents or information to them.
- ▶ Motorbike riders in the area were advised about how their actions were affecting the local community.
- ▶ The team worked closely with partnership agencies to find longer term solutions to issues of anti-social behaviour.

Anti-social behaviour around Clowne Town Centre, Recreation Close and the Community Centre

Issue was set on 05/11/2014

- ▶ Officers carried out high-visibility patrols in hot spot areas to identify groups taking part in anti-social behaviour (ASB).
- ▶ The Clowne Safer Neighbourhood Team interacted with youngsters to deter them from ASB and encouraged them to take part in diversionary activities.
- ▶ Anyone who was caught taking part in nuisance behaviour were advised about how their actions affect others and how it could lead to further involvement from police and partners.
- ▶ Police also spoke to residents about the work that they are doing to offer reassurance in the community.

Nuisance motorbikes in Linear Park and around Clowne

Issue was set on 06/07/2015

- ▶ Officers carried out regular patrols in the Linear Park area to speak to nuisance riders and deter the issue.
- ▶ Motorbike riders advised about the effect their behaviour had on the local community.
- ▶ Further positive action taken where necessary.
- ▶ Worked closely with partnership agencies to find longer term solutions to issues of anti-social behaviour.
- ▶ Local residents encouraged to report any incidents of nuisance behaviour to police on 101 or 999 in an emergency.

Anti-social behaviour in and around the area of Westlea including nuisance vehicles and uninsured drivers

Issue was set on 21/12/2015

- ▶ Regular police patrols were carried out.
- ▶ Officers engaged with and advised any young people, drivers or other individuals of their behaviour and the impact on the local community.
- ▶ Issued Section 59 Warnings where appropriate.
- ▶ Further appropriate positive action taken where necessary.
- ▶ Worked alongside other local partnership agencies to help ensure residents stay and feel safe within the community.
