FREEDOM OF INFORMATION REQUEST - REFERENCE NO: 01/FOI/25/006559/V

I write in connection with your request for information which was received by Derbyshire Constabulary on 09/01/25. I note you seek access to the following information:

Question 1 –

Confirmed or suspected spiking incidents involving vapes or similar over the last 5 years (2020, 21, 22, 23, 24 – i.e. attended / charged / investigated incidents)

I would like this information broken down by the following, where available:

- *Age*
- *Gender*
- *Whether the incident occurred at a place of education, for example school or college*
- *Whether the victim required any treatment at hospital*
- *Date of the incident*
- *The drugs involved i.e. spice, nitazenes*

Background:

I don't know how these offences may be recorded in your system, but the range of crimes listed could include:

- *Administering drug with intent to commit indictable offence*
- *Administering poison so as to endanger life*
- *Use of noxious substances or things to cause harm and intimidate*
- *Administering poison with intent to injure or annoy*
- *Administering a substance with intent*

Please where possible cross reference these offences with records that directly mention spiking and vapes.

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under your Section 16 obligations, as to how I can refine my request to be included in the scope of the Act. In any case, if you can identify ways that my request could be refined, please provide further advice and assistance to indicate this.

Following receipt of your request, searches were conducted within Derbyshire Constabulary to locate any relevant information. The searches located information relevant to your request.

Decision

I have today decided to disclose the located information to you in full.

Question 1 –

Information held.

Searches identified 361 Occurrences with Home Office codes 005/05/01 Administer drug with intent to commit an indictable offence, 008/05/01 Sex – Administer a substance with intent – SOA 2003, 005/10/01 Administer poison with intent to endanger life / inflict grievous bodily harm, 008/02/01 Cause Administer poison with intent to injure/ aggrieve / annoy and the word 'spik', that would pick up spiking, spiked, spike, spikes.

The attached PDF document has information that has identified Vape specific offences.

In relation to this data please note the following:

- The data has been extracted from the Constabulary's Crime System which is, to all intent a 'living' system in that it is constantly being updated. As such the data can only be verified for the date/time extracted.
- Police forces in the United Kingdom are routinely required to provide crime statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the crime data. It should be noted that for these reasons this Constabulary's response to your questions should not be used for comparison purposes with any other response you may receive.

COMPLAINT RIGHTS and COPYRIGHT ISSUES

If you are unhappy with how your request has been handled or you do not think the decision is correct, you have the right to require the Derbyshire Constabulary to review their decision. Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter. That person will be able to discuss the decision, explain any issues and assist with any problems.

Complaint

If you are dissatisfied with the handling procedures or the decision that Derbyshire Constabulary have made under the Freedom of Information Act 2000 (the Act) regarding access to information, you can lodge a complaint with the Derbyshire Constabulary to have the decision reviewed. **However, this request must be made within 40 working days from the date of our response.**

Where possible the Derbyshire Constabulary will aim to respond to your complaint within 40 working days. However, meeting this time scale will depend upon the circumstances and complexity of the issue.

The Information Commissioner

After lodging a complaint with the Derbyshire Constabulary, if you are still dissatisfied with the decision, you may make an application to the Information Commissioner for a decision on whether the request for information has been dealt with in accordance with the requirements of the Act.
