1. *What is your current policy regarding the publication of details for upcoming police misconduct hearings?*
 - *Specifically, when are these details made available on your website?*
 - *How long are they retained and publicly accessible prior to the hearing?*
2. *Following the conclusion of a misconduct hearing:*
 - *When is the outcome published on your website?*
 - *How long is the outcome retained in a publicly accessible format?*
 - *What are the reasons and criteria for withdrawing this information from public view?*
 - *At what point is the information removed from a format that is searchable by the public?*
3. *For each of the following reporting years: 2020–2021, 2021–2022, 2022–2023, 2023–2024, 2024–2025 Please provide the number of misconduct outcomes in which the name of the police officer involved was published and the number of misconduct hearings where misconduct was found.*

Result of Searches

Following receipt of your request, searches were conducted within Derbyshire Constabulary to locate any relevant information. The searches located information relevant to your request.

Information held.

- As soon as practicable after the officer has been notified of the outcome of the proceedings. Regulation 43(7).
- For a period of not less than 28 days – Regulation 43(8)
- In accordance with the police Conduct Regulations 2020
- 28 calendar days – this is then moved to the anonymised published data. See below link:

Question 3 –

Information held.

For each of the following reporting years:

- 2020–2021, (2020) 3 names published – 5 cases resulting in Misconduct/Gross Misconduct being found
- 2021–2022, (2021) 12 Names published – 13 cases resulting in Misconduct/Gross Misconduct being found
- 2022–2023, (2022) 2 Names published – 1 case resulting in Misconduct/Gross Misconduct being found
- 2023–2024, (2023) 7 Names published – 9 cases resulting in Misconduct/Gross Misconduct being found
- 2024–2025 (2024) 11 Names published – 10 cases resulting in Misconduct/Gross Misconduct being found

In relation to this data please note the following:

- The data has been extracted from the Constabulary's Complaints System which is, to all intent a 'living' system in that it is constantly being updated. As such the data can only be verified for the date/time extracted.
- Police forces in the United Kingdom are routinely required to provide statistics to government bodies and the recording criteria is set nationally. However, the systems used for recording these figures are not generic, nor are the procedures used locally in capturing the data. It should be noted that for these reasons this Constabulary's response to your questions should not be used for comparison purposes with any other response you may receive.

COMPLAINT RIGHTS and COPYRIGHT ISSUES

If you are unhappy with how your request has been handled or you do not think the decision is correct, you have the right to require the Derbyshire Constabulary to review their decision. Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter. That person will be able to discuss the decision, explain any issues and assist with any problems.

Complaint

If you are dissatisfied with the handling procedures or the decision that Derbyshire Constabulary have made under the Freedom of Information Act 2000 (the Act) regarding access to information, you can lodge a complaint with the Derbyshire Constabulary to have the decision reviewed. **However, this request must be made within 40 working days from the date of our response.**

Complaints should be made in writing and addressed to **Freedom of Information Officer, Derbyshire Police Headquarters, Butterley Hall, RIPLEY, Derbyshire, DE5 3RS** or via email at foi@derbyshire.police.uk

Where possible the Derbyshire Constabulary will aim to respond to your complaint within 20 working days. However, meeting this time scale will depend upon the circumstances and complexity of the issue.

The Information Commissioner

After lodging a complaint with the Derbyshire Constabulary, if you are still dissatisfied with the decision, you may make an application to the Information Commissioner for a decision on whether the request for information has been dealt with in accordance with the requirements of the Act.
