I write in connection with your request for information which was received by Derbyshire Constabulary on 27/08/2025. I note you seek access to the following information:

Question 1 –

In your police force area, how many incidents of "Asian gold theft" have taken place in 2020, 2021, 2022, 2023, 2024 and 2025 to date.

To clarify: "Asian gold theft" is the theft of gold from Asian families. Criminals are targeting Asian families knowing that many have gold, for cultural reasons.

Please could you specify the number of incidents, and the value of gold stolen if available, per year?

Can you break it down by category too if possible for 1) theft from a person 2) residential 3) commercial

Please could you provide the information in CSV format.

If it's not possible to send all of the above details, can you please send what you have available.

Result of Searches

Following receipt of your request, searches were conducted within Derbyshire Constabulary to locate any relevant information. The searches located information relevant to your request.

The Self Defined Ethnicity of the victim has been recorded. However, we are unable to determine whether the incident was culturally motivated based on the available information.

In relation to this data please note the following:

- The data has been extracted from the Constabulary's Crime System which is, to all intent a 'living' system in that it is constantly being updated. As such the data can only be verified for the date/time extracted.
- Every effort is made to ensure that the data presented is accurate and complete. However, it is important to note that this has been extracted from multiple sources, developed for specific policing purposes, for which data extraction methods have not been specifically designed to directly correlate with the terminology of this request.
- Therefore, the data presented is subject to the inaccuracies and idiosyncrasies inherent in any large-scale recording system.
- As a consequence, care should be taken in the interpretation and presentation of this data, so as to not misrepresent the whole or any part of the data disclosed.

COMPLAINT RIGHTS and COPYRIGHT ISSUES

If you are unhappy with how your request has been handled or you do not think the decision is correct, you have the right to require the Derbyshire Constabulary to review their decision. Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter. That person will be able to discuss the decision, explain any issues and assist with any problems.

Complaint

If you are dissatisfied with the handling procedures or the decision that Derbyshire Constabulary have made under the Freedom of Information Act 2000 (the Act) regarding access to information, you can lodge a complaint with the Derbyshire Constabulary to have the decision reviewed. **However, this request must be made within 40 working days from the date of our response.**

Complaints should be made in writing and addressed to **Freedom of Information Officer, Derbyshire Police Headquarters, Butterley Hall, RIPLEY, Derbyshire, DE5 3RS** or via email at foi@derbyshire.police.uk

Where possible the Derbyshire Constabulary will aim to respond to your complaint within 20 working days. However, meeting this time scale will depend upon the circumstances and complexity of the issue.

The Information Commissioner

After lodging a complaint with the Derbyshire Constabulary, if you are still dissatisfied with the decision, you may make an application to the Information Commissioner for a decision on whether the request for information has been dealt with in accordance with the requirements of the Act.
