I write in connection with your request for information which was received by Derbyshire Constabulary on 15/10/2025. I note you seek access to the following information:

*Please provide the following information relating to the Long Eaton area (postcode sectors NG10 1**, NG10 2**, NG10 3**, NG10 4**, and NG10 5**), please include Acton Road flats operated by EMCH Housing:*

- 1. The number of police call outs, incidents and reports of antisocial behaviour recorded at addresses identified as Houses in Multiple Occupation (HMOs), or otherwise classified as shared accommodation, between 1 January 2021 and 30 September 2025.*
- 2. Where possible, a breakdown of these incidents by street name and type of incident (e.g. noise, disorder, assault, drugs, harassment, criminal damage, etc.).*
- 3. Confirmation of how these incidents are categorised in your recording system (e.g. as ASB, disturbance, nuisance, etc.).*
- 4. Any available heat-map or summary report used internally that shows ASB concentration by street, beat, or ward for the Long Eaton policing area during that period.*

I understand that personal data will be redacted to protect individuals, but aggregated or anonymised data should still be disclosable under the Act.

Result of Searches

Following receipt of your request, searches were conducted within Derbyshire Constabulary to locate any relevant information. The searches located information relevant to your request.

Decision

I have today decided not to disclose all the information requested in your question 8 as I am claiming an exemption under Section 21 - Information accessible by other means.

Consequently, please accept this letter as a formal refusal for this part of your request.

Refusal of Request – Section 17

Section 17(1) provides that –

“A public authority which, in relation to any request for information, is to any extent relying on a claim that any provision of Part II relating to the duty to confirm or deny is relevant to the request or on a claim that information is exempt information must, within the time for complying with section 1(1), give the applicant a notice which –

- (a) States that fact,
- (b) Specifies the exemption in question, and
- (c) States (if that would not otherwise be apparent) why the exemption applies.”

Section 21 - Information which is reasonably accessible

The information requested is reasonably accessible to the applicant otherwise than by response through Section 1 the Freedom of Information Act 2000.

This is an absolute and class-based exemption and, as such, I am not required to complete either a public interest or harm test on the issue of disclosure.

COMPLAINT RIGHTS and COPYRIGHT ISSUES

If you are unhappy with how your request has been handled or you do not think the decision is correct, you have the right to require the Derbyshire Constabulary to review their decision. Prior to lodging a formal complaint you are welcome and encouraged to discuss the decision with the case officer that dealt with your request.

Ask to have the decision looked at again

The quickest and easiest way to have the decision looked at again is to telephone the case officer that is nominated at the end of your decision letter. That person will be able to discuss the decision, explain any issues and assist with any problems.

Complaint

If you are dissatisfied with the handling procedures or the decision that Derbyshire Constabulary have made under the Freedom of Information Act 2000 (the Act) regarding access to information, you can lodge a complaint with the Derbyshire Constabulary to have the decision reviewed. **However, this request must be made within 40 working days from the date of our response.**

Complaints should be made in writing and addressed to **Freedom of Information Officer, Derbyshire Police Headquarters, Butterley Hall, RIPLEY, Derbyshire, DE5 3RS** or via email at foi@derbyshire.police.uk

Where possible the Derbyshire Constabulary will aim to respond to your complaint within 20 working days. However, meeting this time scale will depend upon the circumstances and complexity of the issue.

The Information Commissioner

After lodging a complaint with the Derbyshire Constabulary, if you are still dissatisfied with the decision, you may make an application to the Information Commissioner for a decision on whether the request for information has been dealt with in accordance with the requirements of the Act.
